

## Webstyleshare.com Terms & Conditions

### Important

Webstyleshare.com is a division of Giantreferrals.com LLC. As such, where applicable, you are bound by the terms and conditions of Giantreferrals.com LLC. The terms Webstyleshare.com and Giantreferrals.com may, for purpose of these terms and conditions, be used interchangeably. Please read this Member Agreement (the “Agreement”) carefully before enrolling as a member or agent of the Giantreferrals.com LLC (the “Company”) program (the “Program”) or using any Giantreferrals.com software (“Software”). This Agreement explains the terms and conditions governing membership in the Program (the “Program Terms and Conditions”), and it is your responsibility to read and understand them. By enrolling as a member in the Program (“Member”), or by utilizing Software, you agree to be bound by the Program Terms and Conditions. Enrollment is defined as providing Giantreferrals.com with your valid email address and a password in which to access your account. Utilizing Giantreferrals.com software does not confer the status of “Member” until the Software user completes the enrollment process. Participation in the Program and its benefits are offered at the discretion of Giantreferrals.com, and Giantreferrals.com has the right to change the Program Terms and Conditions, in whole or in part, at any time with or without notice. All members agree to receive email notifications from Webstyleshare.com and Giantreferrals.com, its parent company. Should a member disagree with the current or future modifications of terms and conditions the member’s sole recourse is to withdraw from the program and forfeit any future compensation that otherwise would be eligible as an active member in good standing. Webstyleshare.com is a marketing and advertising tool that relies in part to third party software programs. In the event that any of these third party program providers or any government agency limits our access to their software, our member’s sole recourse will be to withdraw from the program if no viable alternative is readily available. All members in good standing and eligible for compensation will continue to receive compensation from the company for as long as the company remains in existence and under control of the company founders. Ad banner images stored on the company’s active servers may be used in the company’s promotional advertising. All monetary references within are in US dollars.

### Member Definitions

1. **Free member** – a free member also referred to as a member, subscribing to and paying no monthly membership fee. The Free Member agrees to only use the system legally. Should a Free Member use the service in any way not conforming to Federal or State law, they will be prohibited from use of service and will be held fully liable for all legal costs and or punitive damages associated with the problematic usage.

2. **Silver Member** – A member subscribing to and paying for our silver membership as defined in the paragraph labeled **cost of use**.
3. **Gold Member** A member subscribing to and paying for our Gold membership as defined in the paragraph labeled **cost of use**.
4. **Platinum member** A member subscribing to and paying for our Platinum membership as defined in the paragraph labeled **cost of use**.
5. **Member** – All free and premium members of Webstyleshare are independent members and are in no way deemed employees of the company.
6. **Affiliated business** – a business that may compensate the company.
7. **Affiliate Program** – All members are eligible to participate in the company affiliate programs whereby they may be compensated by the company.
8. **The Company** – Refers to Giantreferrals.com’s company and its divisions and products.
9. **Referral ID** – Each member is assigned a referral ID. The referral ID is used to track members who refer new members and to compensate those eligible individuals.
10. **Promo Code** – Promo codes are codes used for special promotions offered by the company. Referral ID’s entered in the Promo Code field when a new account is being established will allow for the company to identify and compensate those eligible individuals.
11. **Multi Level Marketing** – The Company IS NOT a multi level marketing company. Members may be eligible for compensation only for directly referred premium members which is tracked by the Referral ID associated with the new account at time of account creation.
12. **Webstyleshare Groups** – Groups that Premium Members may create for the purpose of cross-marketing between members. Premium members are eligible to receive monthly compensation for

- each active member of their group in good standing. Premium members in good standing are also eligible to receive compensation in the amount of \$1.00 per group member established by his or her referral.
13. **Good Standing** – Good standing refers to members following the rules of the most up to date terms and conditions including timely payment of membership fees.
  14. **Inactive Accounts** – Accounts with no active usage for 6 months or greater as determined by the last date of log in will be deemed defunct and not eligible for compensation distribution. Earnings from inactive accounts will be deemed earned revenue of the company.
  15. **Suspension or Termination** – Failure to comply with the of the most current set of terms and conditions will result in suspension or termination from usage of the company’s products and the forfeiture of any current of future compensation that was a result of that account.
  16. **Refunds** – The company policy is NO REFUNDS. However, all services are month to month and may be cancelled any time unless subject to any special savings promotion code that was in affect and submitted at time of purchase.
  17. **Setup Fee** – a one-time fee charged when establishing a premium account.
  18. **Monthly Membership Fee** – a monthly fee charged for receiving the benefits and compensation offered to all premium members.
  19. **PayPal** – Paypal is the current service used for the distribution of member compensation. A Paypal account is required for distribution of compensation without additional fees. Members requesting any other distribution method will be subject to a processing fee equal to 10% of the distribution.
  20. **Minimum Compensation Distribution** – Members earning compensation will only be distributed upon reaching earnings of \$25 or greater at date of distribution.

## Eligibility

1. You must be an individual, 18 years of age or older.
2. Members must be human: no machines, scripts, or automated services may be used to accumulate any financial benefits derived from the use of Giantreferrals.com and or Webstyleshare.com software. You may maintain only one account for each individual service. Any duplicate accounts will be subject to cancellation.
3. You must have Internet access and an email address to be eligible to receive the privileges and benefits of membership. Giantreferrals.com is not responsible for your inability to connect to the Internet, log into the Webstyleshare.com web site, or access your Webstyleshare.com account.
4. By agreeing to these terms, you also agree not to 'spam' unknown individuals by sending them unwanted emails to solicit their membership to Webstyleshare.com or Giantreferrals.com. Refusal to abide by this or any other rules may result in the company canceling your membership.

## Costs for use of service

Webstyleshare.com offers 4 packages. **FREE, SILVER, GOLD, and PLATINUM** – The selected membership fee is required in full at time of registration. Recurring billing shall occur each month at or near the day of initial registration of a premium account.

### **What's included Free Account**

Subscribers get use of one (1) advertising banner spot that will be displayed when a video advertising link is created and shared. All other Ad banner spots are reserved for the company to use at its discretion.

Referral Compensation: Receive 10% of the monthly membership

Duration of Compensation: Up to 1 year

Setup Fee Compensation: Receive 10% of the \$200 Setup fee (\$20.00)

Company Sponsored Third Party Affiliate Advertising Compensation: Eligible at ½ premium member compensation.

Group Compensation: Not eligible

Sub Group Compensation: Not eligible

### **What's included for \$20/mo (SILVER PACKAGE)**

Subscribers get use of three (3) advertising spots as well as use of the Coupon Generator Tool and the ability to view usage statistics in the product dashboard (WEBSTYLESHARE.COM).

Referral Compensation: Receive 25% of the monthly membership.

Duration of Compensation: Lifetime for members remaining in good standing.

Setup Fee Compensation: Receive 80% of the \$200 Setup fee (\$160.00)

Company Sponsored Third Party Affiliate Advertising Compensation: Fully eligible

Group Compensation: Receive 25% of the \$20 monthly membership fee (\$5.00)

Sub Group Compensation: Receive \$1.00 for each of your referred premium member's Group

#### **What's included for \$50/mo (GOLD PACKAGE)**

Subscribers maintain use of all four (4) advertising spaces and the ability to maintain 3 separate advertising campaigns as well as use of the Coupon Generator Tool and the ability to view usage statistics in the product dashboard (WEBSTYLESHARE.COM)..

Referral Compensation: Receive 25% of the monthly membership.

Duration of Compensation: Lifetime for members remaining in good standing.

Setup Fee Compensation: Receive 80% of the \$200 Setup fee (\$160.00)

Company Sponsored Third Party Affiliate Advertising Compensation: Fully eligible

Group Compensation: Receive 25% of the \$20 monthly membership fee (\$5.00)

Sub Group Compensation: Receive \$1.00 for each of your referred premium member's Group

#### **What's included for \$150/mo (PLATINUM PACKAGE)**

Subscribers get use of all 4 advertising spaces as well as use of the Coupon Generator Tool and the ability to view usage statistics. You will have the ability to create three sales campaigns for up to five separate business entities.

Referral Compensation: Receive 25% of the monthly membership.

Duration of Compensation: Lifetime for members remaining in good standing.

Setup Fee Compensation: Receive 80% of the \$200 Setup fee (\$160.00)

Company Sponsored Third Party Affiliate Advertising Compensation: Fully eligible

Group Compensation: Receive 25% of the \$20 monthly membership fee. (\$5.00)

Sub Group Compensation: Receive \$1.00 for each of your referred premium member's Group

#### **Company Sponsored Third Party Affiliate Advertising Compensation:**

Members who choose to utilize the company sponsored Affiliate banners will share in the pooled company earnings of each of the company affiliated firms. The company will fund the pooled affiliated accounts with a portion of company earnings from affiliated firms.

Compensation will be based on points earned on accumulated clicks on each of the company sponsored affiliate banners. Free account holders will accumulate ½ of that of Premium account holders with exception of and bonus offers. Direct link to affiliated companies using our Shop & Share feature will accumulate points at double that of indirect clicks. Distribution of earnings will be based on the percentage of points earned relative to the pool of members utilizing the company affiliated banners in a given monthly period. Distribution of earnings shall take place by the 15<sup>th</sup> of the following month. Payouts will occur via Paypal as defined in member definitions.

**Viral Ads - Social Media advertising feature:** Cost: Non-refundable processing fee of 20% of all account funding transactions. A minimum transaction fee of \$10 will be assessed for funding amounts of less than \$50. Additional costs: the fee offered to other members for posting ad links.

This extremely powerful function is available for use on all above listed packages!

**Viral Ads - Business Owner/Advertiser:**

This function gives all of our subscribers the ability to take advantage of the power of **other** subscribers posting advertising links on their own social media outlets for a payment of your own choosing. Users choosing to share your designated webstyleshare.com advertising links may receive your designated payment.

For Example: If you fund your account with \$100, your total cost will be \$120 (100+20% transaction fee). Should you offer other members the amount of \$1.00 to post your webstyleshare.com advertising link within their social media accounts, your advertising links may be shared by 100 other members until your either the account has been exhausted (\$100/\$1.00 = 100 posts) or until you add additional funds in your account. Members also have the ability to limit the daily and total posts to control their advertising budget.

Monies deposited in by members into their accounts shall bear no interest.

#### **Viral Ads - Social Media Member-Poster:**

This function gives all of our subscribers the ability post other member's webstyleshare.com created advertising links on their own social media accounts for the fee offered by the advertising member. Upon posting the available link on the member's personal social media outlet, the Member-Poster shall be credited with 50% of the posted amount to their PENDING 3 VIEWS ACCOUNT and 50% to the member's PENDING 1K VIEWS account.

#### **PENDING 3 VIEWS ACCOUNT:**

In order to earn the pending 50% of the fee made available by the advertising member, the posted link must receive 3 views from 3 separate IP addresses within 24 hours of the posted date and time. Failure to receive the required 3 views will result in the posting being deemed ineligible to receive payment. The 50% allocated fee will be credited back to the advertising member. Should the posting receive the required 3 views, the member's Pending 3 View Account will be debited and the member's EARNED account will be credited.

#### **PENDING 1K VIEWS**

In order to earn the pending 50% of the fee made available by the advertising member, the posted link must receive 1000 views within 30 days of the post, that the member's Pending 1K View Account will be debited and the member's EARNED account will be credited; otherwise the balance shall be forfeited and deemed earned income to the company Giantreferrals.com LLC.

Monies accumulated into **member accounts** links shall bear no interest.

#### **Payments of accrued EARNED amounts:**

\*\* Payments for posting links will be accumulated in the member's account until the member accumulates earned revenue of \$25 or more. Payout requests for amounts less than \$25 will be assessed a \$2.50 transaction fee. Member's earning \$600+ will be required to provide the ENTITY NAME, ADDRESS & Tax ID information such that Giantreferrals.com will have sufficient means to provide an IRS form 1099 before any additional earnings will be released. Accounts deemed dormant (no activity for 12 months or more) shall forfeit any accumulated revenue to Giantreferrals.com.

**Webstyleshare GROUPS:** Cost: All Premium members may create their own group or series of groups and for no additional charge. Webstyleshare members who establish groups will earn \$5.00 per month per member that joins their group.

Note: When joining a group that member agrees to abide by the organizer's group requirements. The group organizer will have access to your email address for purpose of group correspondence. Your membership in a group may be terminated at any time and for any reason by you or the group organizer. There will be NO REFUNDS FOR ANY REASON. Monthly group membership fees will cease on the following billing cycle.

Webstyleshare.com management reserves the right to terminate any GROUP for any reason at any time and without compensation. Your sole recourse will be to cease using the Webstyleshare.com software.

## Helpful Notes: How to increase revenue by using Webstyleshare.com

1. Members may increase sales by advertising their own business or products by properly using the Webstyleshare.com tool.
2. Members may refer other members to use the service. The referring member will earn 25% of the monthly fee for any new member that signs up for a fee based subscription. Members will continue receiving the monthly residual payments for as long as they remain an active member and the referring member's registrant remains a paying customer in good standing.
3. Members may personally sell individual ad spots on their Webstyleshare.com created pages.
4. Become an independent referral agent of Webstyleshare.com and have the ability to earn 25% by selling zip codes to Graphic artists and Videographers.

When sharing videos, it is the member's responsibility to only share unrestricted and non copyrighted videos.

### **Initial Setup Fees**

Initial Setup Fees are earned by a referring member minus a 10% processing fee. Webstyleshare.com allows referring members to charge an optional one-time setup fee to prospective clients to whom the member has given a demonstration. The company makes no requirements on part of the referring member for charging a setup fee other than the establishment of a new premium account. Separate oral or written agreements between a referring member and a new member are not endorsed by company and as such will be the sole responsibility of the member(s) to resolve. Complaints implicating otherwise may result in the termination of the offending member from Webstyleshare.com and forfeiture of all future earnings. Earned setup fees will be paid with normal payment distribution cycles.

### **Payment Schedule**

1. Money earned through the Giantreferrals.com Webstyleshare.com program will be paid as per the payment schedule posted within and is subject to change at any time. The program may be modified or terminated, at any point, and without notice. All accrued earnings will be paid in full through point of termination.
2. Giantreferrals.com pays its members monthly.

Giantreferrals.com is not responsible for any misapplied payments or payments sent to the wrong address if these errors were caused by inaccurate email or contact information provided by you, though we will work hard to resolve any such issues should they arise.

1. Upon registration, members will select a password that will allow access their Webstyleshare.com dashboard to verify payments, check account balances, modify account information or change
